RULES: THE SCOUT LAW

- 1. NO firearms, fireworks, bows and arrows or ammunition of any kind are permitted on camp property.**
- 2. ALL cars must be parked in the camp parking lot. ONLY CAMP vehicles are permitted past the parking areas. Speed limit on all roads is 15 MPH!**
- 3. NO alcoholic beverages or unlawful drugs.**
- 4. ALL units must have a permit to check-in. Report to Camp Ranger or Campmaster—each unit must also check-out with Camp Ranger or Campmaster.**
- 5. A troop must have adult leadership at all times during the troop's stay in camp.**
